MINUTES of the **NEIGHBOURHOOD COUNCIL MEETING** held on Wednesday the 1<sup>st</sup> March 2017 @ St Margaret's Church Hall Ingol commencing at 7.00pm

Present: Cllrs McGrath, Bevan, Ellison, Thompson, Buchner, Darby (who arrived after the meeting had commenced), Brookes and Roskell

There were six members of the public present.

Since both the Chairman and Vice Chairman were not present at the commencement of the meeting Cllr Roskell was elected to take the Chair.

10/17 To receive apologies

11/17 To approve the Minutes of the Meeting held on the 11<sup>th</sup> January 2017 (enclosed)

It was resolved that the Minutes of the meeting held on the 11<sup>th</sup> January 2017 should be approved and signed by the Chairman as a true and accurate record

Cllr Darby (Chairman) arrived at this point and took the Chair.

12/17 To receive Declarations of Interest

Declarations of personal and prejudicial interests were received from Cllrs Brookes, Ellison and Thompson in respect of item 5 on the agenda since they were all members of an action group (IGVRA) who opposed any development for housing on Ingol Golf course. They all left the room during the debate and voting on this item however they reserved the right to make a statement of representation prior to leaving the room.

13/17 To adjourn the meeting for a period of public discussion

The meeting was adjourned

A member of the public asked what had happened to the two planters mentioned in the previous meeting minutes since they had not been installed as planned. It was explained that in moving them they had disintegrated and were therefore not able to be relocated as planned. She expressed concern that the planters had not been evenly distributed across all the neighbourhood. It was explained that the decision as to location had been made a few years ago, and that it was open to any member to put forward an agenda item to either re-locate or install more planters if they so wished.

It was noted that the litter pickers seen in the area work for Preston City Council although our own lengthsman does undertake some additional litter picking from time to time.

Concern was expressed at the cost of the bulb planting on Nog Tow roundabout. It was felt that the money could be better spent.

It was stated that residents should support Ingol Golf Club as a local community facility especially now that arguments were being out forward to suggest that it was 'surplus to requirements' as part of a planning

application to develop 450 dwellings on the open space which it currently occupied and that new housing should not be allowed.

*Clarification regarding 'Declarations of Interest' and the 'Code of Conduct' was provided by the clerk for the information of the public who were concerned that some of their elected representatives who were against development of Ingol Golf Course would be excluded from that agenda item.* 

## The meeting was reconvened

Cllr Darby declared a personal and prejudicial interest in item 5 on the agenda relating to the planning application for Ingol Golf Course due to him being a Liberal Democrat City Councillor whose party, and who himself had already expressed their views against any such development. He left the room during the debate and voting on this item however he reserved the right to make a statement of representation prior to leaving the room.

Prior to the discussion and debate on the following agenda item those members who had declared prejudicial interests made statements against the proposed development siting several National and Local Planning Policies (NPPF Clause 74 – Core Strategy Policy 19 – Preston Local Plan Policies EN2 and EN5) which they felt would be contravened should the application be given permission – they also referred to previous applications for housing development on this site which had been refused, had gone to appeal and where the appeal inspector had upheld the refusal decision by Preston City Council based on these policies. It was explained that the polices mentioned did allow for development but only in very limited circumstances one of which was that the existing usage was surplus to requirements. The developers had produced a report to support their contention that Ingol Golf Course was not viable and therefore surplus to requirements. It was suggested that this report was significantly flawed and that the facilities were in fact very important as community recreational provision for the area. They all asked the Council to object to the development for the above-mentioned reasons.

## Cllr Roskell was elected to take the Chair for the following item due to the Chairman (Cllr Darby) having left the room due to his Declaration of Interest (the Vice Chairman not being present)

14/17 To consider Planning Application 06/2017/0002 being a hybrid application for the development of Ingol Golf Course into a new Preston NE training facility, open space improvements and the erection of up to 450 dwellings.

## CENTRAL LANCASHIRE EMPLOYMENT LAND STUDY

Preston City Council, working with its neighbours in Central Lancashire South Ribble and Chorley Borough Council, has commissioned BE Group to undertake an Employment Land Study for the whole Central Lancashire Sub-Region. This is required to provide a common evidence base for all three local authorities on employment matters, to compliment the sub-region wide Strategic Housing Market Assessment also being produced. The evidence will be used to support the development of Local Plan documents for the Central Lancashire area. It will include a comprehensive study of the need and demand for office, manufacturing and warehouse space across the whole of Chorley, Preston and South Ribble.

As part of the study BE Group is consulting with key stakeholders and in this respect they are seeking the views of your Parish/Town Council regarding supply and demand/need for employment sites and premises in your area. It may be, for example, that there are buildings or sites in your local area which you wish to see redeveloped. It may be that the Parish/Town Council considers there is a need to provide more local employment opportunities. Other possible views could relate to:

- A need for more sites for employment development
- A requirement for improved office/industrial premises supply
- A desire to attract employers to your area
- A wish to encourage more people to work locally
- The protection of the local area from unwanted development.

These are just examples. It is recognised that each Parish/Town Council varies in size, population, employment activity, etc. and may therefore have differing views or issues. Preston City Council would be grateful, therefore, if you could highlight this matter at your next Parish/Town Council meeting. weekends and during the holidays, groups of youths are climbing over fences at the back of At school we are having real issues with vandalism at the moment. After school hours, at our school grounds on to our school field. They are then climbing on to our school roof – which as you know is a flat roof and covers a wide area.

sail which is located in a garden area at the back of school. The sail was built as a sunshade -The youths are then running across the roof, causing damage. They have tried to set light to the perspex windows on the roof. They also frequently jump from the roof on to an outdoor it was not built as a slide. There is also the worry that there could be a serious accident as there is a big drop from the sail to the ground if anyone jumps and misses their target.

The garden area has been wrecked three times in this school year, trellises pulled off the wall, the greenhouse has been destroyed and planters have been broken and soil thrown everywhere. There has also been damage to the reception outdoor area . There is a wooden chalet that has had windows broken and the door pulled off its hinges. Other toys are also thrown around and many destroyed.

We are very proud of our school and do find it upsetting to see the damage that has been caused and are looking for a solution to stopping the vandalism.

period. Damage was caused at the front of the school where an "Early learning centre" is situated. Wooden trellises were torn from responsible. Damage was also caused around the rear of the building where the offenders had climbed into an enclosed area of the On 20<sup>th</sup> February 2017 police were called in relation to damage caused at the school which had occurred over the school holiday the walls and smashed up. A small playhouse had the roof damaged and plant pots and soil were thrown all over the area. The caller reported the group were on the school roof the Monday before but she could not state if it was the same persons

On 22<sup>nd</sup> December 2016 at 18:30 hours police were called regarding youths on the school roof of the primary school. A patrol

attended but the group had made off prior to police arrival.

On 6<sup>th</sup> July 2016 at 20:12 hours another report to police re 6 youths on the school roof causing problems. They had been there around 30 minutes. Police attended, no trace

On 17<sup>th</sup> April 2016 at 17:47 another call re youths on the school roof. Police attend but no trace

Another call on 17<sup>th</sup> April 2016 regarding youths on school roof, same time as above.

On 10<sup>th</sup> April 2016 police were called by a passer by in relation to 6 youths on the school roof. Police caught up with 3 youths in the nearby area. These youths were taken home and verbally warned infront of parents before youth referral were submitted

On 14<sup>th</sup> Feb 2016 police were called by a security guard from group 4 reporting being called to an intruder alarm at the school. When he arrived there were lots of teenagers on the school roof. A group were seen to run off once police were in the area.

On 13<sup>th</sup> Jan 2016 an informant nearby the school rang to report the school alarm was going off. Patrol attended but no issues reported On 7<sup>th</sup> Jan 2016 police were called re damage caused the night previous to the school roof skylights. There was also evidence they had tried to start a fire to the frames surrounding the skylights. A childrens play house outside was also damaged. Crime undetected, no offenders identified On 6<sup>th</sup> Jan 2016 another call reporting youths on the roof of the school, also reported to be throwing stones at the windows. Local officers attend but no trace of the youths
